

VDAF RAFFLE CONTEST RULES

As part of the Virginia Dental Association (VDA) Annual Meeting, the Virginia Dental Association Foundation (VDAF) will raffle an intra-oral camera (estimated value \$ 3,499), (the "Contest"), on the terms and conditions described in the Official Rules below. The net proceeds from the Contest will be used to benefit the mission and programs of VDAF.

One valid entry per raffle ticket purchased.

You must be 18 years of age or older at time of entry to be eligible for this contest.

Winners will be notified in person or by email. If a winner is unreachable after seven (7) days, or if that winner is unavailable for prize fulfillment, an alternate winner will be selected. If the Virginia Dental Association Foundation (VDAF) or its affiliates cannot find an eligible winner for the prize, that prize will not be awarded.

It is anticipated that tickets will be sold at the VDA Annual Meeting, at events throughout Virginia, in personal transactions by VDAF staff and volunteers, and online at the VDAF website.

A maximum of 1,000 tickets will be sold. Odds of winning depend on the number of eligible entries received. No purchase (tickets, gifts, etc.), contribution, or other financial support of VDAF is necessary to purchase raffle tickets. All ticket sales will be conducted pursuant to procedures promulgated by VDAF. Each ticket sold will bear a unique number, and will have a counterpart stub bearing the same number and requiring provision of the following information by the purchaser: name, physical mailing address, telephone number, email address, and payment information. Only tickets whose counterpart stubs have been filled out and permit identification and location of the purchaser will be eligible to win the Contest. There is no limit to the number of tickets an individual may purchase, up to the maximum number of tickets available. Each ticket must be filled out in the name of a single individual. Tickets are nonrefundable. All online ticket sales will cease at 12:01 am on September 15, 2017 or when supplies run out, whichever occurs first.

Ticket sales at the VDA Annual Meeting will cease at 5:00 pm on September 15, 2017 or when supplies run out, whichever occurs first.

Contest winners will be selected at random drawings on September 16, 2017, to be held at approximately 9:00 pm. Entrants do not need to be present to win.

This Contest is void where and to the extent prohibited by law and is subject to all applicable laws, including, without limitation, federal, state, and local laws and regulations. In the event of non-compliance by any winner with the official rules of this Contest, an alternate winner may be selected. Prizes are non-transferable. Except where legally prohibited, acceptance of any prize constitutes permission for VDAF to use each winner's name, photograph, likeness, voice, address (city and state) and testimonials, in printed, broadcast or other media, whether now known or hereafter developed, in perpetuity, in any manner it deems appropriate in connection with promoting this or any other Contest and/or promotion sponsored by it, without further compensation to the winner.

VDAF and its affiliates reserve the right to substitute any prize with another prize of equal or greater value.

The following persons, and any spouse, sibling, parent or child of such person, are disqualified from participating in the Contest:

- a. The person operating the hopper in which all purchased tickets have been placed;

- b. The person selecting the winning ticket from all purchased tickets;
- c. Any person with access and authority to modify the list of ticket purchases;
- d. Any person possessing or with access to ticket purchase stubs;
- e. Any person possessing or with access to ticket purchase funds following the close of ticket purchases;
- f. Any employee, officer or director of VDA, VDAF;
- g. Any member of the immediate family of the foregoing.

Contest entrants agree to abide by the terms of these Official Rules and by the decisions of the VDAF, which are final on all matters pertaining to the contest.

Entrants further grant to VDA and VDAF and its affiliates the right to use and publish their proper name, photo and likeness online and in print, or any other media, in connection with the Contest.

VDAF and its affiliates reserve the right to use any and all information related to the Contest, including information on contestants obtained through the contest, for marketing purposes or any other purpose, unless prohibited by law.

The Contest and all of the related pages, contents and code are copyright Virginia Dental Association Foundation and/or its affiliates. Copying or unauthorized use of any copyrighted materials, trademarks or any other intellectual property without the express written consent of its owner is strictly prohibited.

VDAF reserves the right to substitute any prize with another prize of equal or greater value. The prize cannot be exchanged for cash. If the winner elected to accept the prize, that winner assumes liability for and must pay all federal, state and local excise (including gambling), sales, income, and other taxes when the prize is transferred to the winner. VDAF assumes no responsibility for the winner's tax obligations and suggests that all entrants consult their tax advisor. Winner will be required to complete an IRS form W-9. VDAF reserves the right to withhold prizes until completed form W-9 is received.

Each winner, by acceptance of the prize, agrees to release all Sponsors, and their parent and subsidiary companies, their officers, directors, employees, agents, shareholders, affiliates, suppliers, distributors, and advertising agencies from all liability, claims, or actions of any kind whatsoever for injuries, damages, or losses to persons and property which may be sustained in connection with the receipt, ownership, or use of the prize.

All entrants further agree that in the event of any third party claims, damages, losses or injuries, arising from or relating to such entrant's participation in this Contest, such entrant will indemnify and hold Promoters harmless from and against any and all such claims, including reasonable attorneys' fees related thereto. Promoters shall not be liable for entries that are delayed, lost, misdirected, misdelivered, incorrect or incomplete, and such entries will be not be eligible for this Contest. Promoters shall not be responsible for any technical malfunctions of any telephone network, computer on-line system, computer equipment or software;

program malfunctions or other failures; delayed computer transactions or network connections; any errors of any kind, whether human, mechanical or electronic; or any combination thereof, including, without limitation, any injury or damage to the computer of any entrant or any other person related to or resulting from downloading any part of this Contest.

By receipt of the prize, winner agrees to execute any releases and other documentation and agreements as requested by VDAF, to release and hold harmless VDAF, its affiliates, subsidiaries, advertising/promotion agencies, and prize suppliers, and each such entity's officers, directors, employees and agents, and all volunteers working on the Contest (collectively, the "Released Parties") from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Contest or receipt or use or misuse of the prize.

VDAF reserves the right to cancel, suspend and/or modify the Contest, or any part of it, if any fraud, technical failure or other factor beyond its reasonable control impairs the integrity or proper functioning of the Contest, as determined by VDAF in its sole discretion. VDAF reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the Contest process or to be acting in violation of these Official Rules or in any disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, VDAF reserves the right to notify appropriate law enforcement authorities and seek damages or other civil remedies from any such person. VDAF's failure to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

The Released Parties are not responsible for: (1) any incurred or inaccurate information, whether caused by them, by Contest purchasers, by printing errors or by any of the programming associated with or utilized in the Contest; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or computer hardware or software; (3) unauthorized human intervention in any part of the Contest process; (4) technical or human error which may occur in the administration of the Contest or the processing of Contest ticket purchase; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Contest purchaser's participation in the Contest or receipt or use or misuse of the prize.

If for any reason a Contest ticket is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, a ticket purchaser's sole remedy is another ticket in the Contest.

Except where prohibited, Contest purchasers agree that: (1) any and all disputes, claims and causes of action arising out of or connected with this Contest shall be resolved individual, without resort to any form of class action, and exclusively by the appropriate Virginia State Court located in Chesterfield County, Virginia; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event including attorneys' fees; and (3) under no circumstances will Contest ticket purchasers be permitted to obtain awards for, and each participant hereby waives all rights to claim, (a) indirect, punitive, incidental and consequential damages, (b) any other damages other than for actual out-of-pocket expenses, and (c) any and all rights to have damages multiplied or otherwise increased.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and VDAF in connection with the Contest, shall be determined by VDAF in its sole discretion, which determination shall be final and binding, and shall be governed by, and construed in accordance with, the laws of the State of Virginia without giving effect to any choice of law or conflict of law rules (whether of the State of Virginia or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Virginia.
