

OFFICIAL RULES FOR THE VDA FOUNDATION GIFT CARD GIVEAWAY CONTEST  
NO PURCHASE NECESSARY TO ENTER OR WIN.

By entering or participating in the VDA Foundation Gift Card Giveaway Contest (the "Contest"), you agree to all of the following rules:

Contest Rules:

No purchase necessary. Any error or omission in the information on the entry form voids the entry. Limit one entry per person. If multiple entries are received from any person, only one entry will qualify for the random drawing or the entrant may be disqualified from the Contest. Contest entrants agree to abide by the terms of these Official Rules and by the decisions of the VDA Foundation ("VDAF") regarding the Contest.

You must be 18 years of age or older and a United States resident at time of entry to be eligible for this contest. This contest is void where prohibited by law. Entries are the property of VDAF and will not be returned. Entrants need not be present at the drawing to win a prize.
